

PROGRAM SERVICES



BY THE NUMBERS

In 2022, the Foundation raised more than **\$400,000** for programs that support agriculture education, leadership development, and health and safety.

Hosting over 200 individuals for the inaugural Minnesota Ag Day Gala, the Foundation raised more than **\$15,000** for its programming and outreach efforts.

28 county Farm Bureaus received more than \$2,750 from the Foundation in grant funding to assist with hunger solutions in their communities. Those counties were able to leverage their grants and raise over \$10,000 in additional support.

With the help of Farm Bureau members, the Foundation promoted the removal of unused prescription medicines from homes by distributing over **27,000** Deterra Prescription Drug Disposal kits to families across the state.

51 county Farm Bureaus received more than **\$37,000** in agriculture promotion grant funding, supporting outreach to connect consumers to agriculture and raise awareness about its role in Minnesota.

The Foundation wrapped up a pair of two-year capital fund campaign commitments in 2022: **\$10,000** to the Robert A. Christiansen Pavilion to update the swine facility at the Minnesota State Fair and **\$5,000** to FarmAmerica near Waseca for expansion and renovation of its existing facilities.

Six undergraduate students received
Foundation scholarships. Statewide,
23 organizations received funding from the
Foundation, totaling over \$32,000.

78 farms were recognized as Century Farms and **36 farms** were recognized as Sesquicentennial Farms in 2022. Both programs are supported by the Foundation.













Foundation Fun Night

The inaugural Foundation Fun Night Carnival took place during the 2021 Minnesota Farm Bureau Annual Meeting, raising over \$8,500. Attendees had a fun-filled evening playing games, participating in raffles, and bidding on items during the live auction.

LEAP Conference

During the 2022 Leadership, Education, Advocacy and Promotion (LEAP) Conference, the Foundation along with the Minnesota Farm Bureau Young Farmers & Ranchers Committee and the Promotion & Education Committee raised over \$3,000 and collected hundreds of socks for the "Sandwich Guy" and Minneapolis Recreation Development Inc.



Additionally, over \$28,000 was raised in sponsorships.



Annual Golf Scramble

The Foundation held its annual Golf Scramble at River Oaks Golf Course in June, raising over \$13,000. Thank you to all of the sponsors, prize donors, participants and especially Farm Bureau Financial Services, who plays a special role in making this event a success each year.

Farmfest

The Foundation team and over 50 Farm Bureau volunteers sold nearly 4,200 pork chops, raising more than \$8,000 during the three-day event. In addition to the pork chop sales, the Foundation sponsored the Farm Health & Safety Tent and the Mobile Health Trailer, and hosted the Rx Abuse Leadership Team to discuss the Opioid Crisis in rural Minnesota.



Online Auction

The Foundation held its second-annual online auction in the spring, raising over \$7,000. The auction provides an opportunity for members and supporters across the state who may not be able to attend other fundraising events in person to give back to the Foundation.

2022 AG DAY GALA



The inaugural Ag Day Gala was a special night, bringing together hundreds of individuals to celebrate the diversity and contributions of agriculture in Minnesota.

Hosted on March 22 at the Green Acres Event Center in Eden Prairie, the evening honored the strong past of agriculture in the state, while looking forward to the future.

The social hour featured locally-sourced cheeses, meats and cocktail service. Afterward, attendees moved into the dining space where they were treated to a four-course dinner that included entrees putting the state's top commodities in the spotlight. Even the dessert course had a Minnesota twist.

During the program, Foundation Director Ruth Meiricl brought to light how everyone in the room was connected by agriculture. Uniting strips of paper attendees signed as they registered into a long chain, she emphasized the importance of everyone in attendance continuing to work together to keep the industry strong.

The Foundation looks forward to continuing this great showcase each March on National Ag Day.

Ag Promotion Grants

Foundation Ag Promotion Grants are designed to support the work of county Farm Bureaus and their local outreach efforts. In 2022, the Foundation awarded more than \$37,000 for farm safety, education, leadership and other programming hosted by counties. The grant is possible through the generosity of the Minnesota Farm Bureau Federation.

Each year we highlight a county Farm Bureau who supported the grant's focus with a new or unique program.

The Dakota County Farm Bureau participated in the 2021 Hastings Halloween Community Event where they handed out milk, cheese sticks, pencils and coloring books to event participants.

A few months later they took part in the Santa on the Farm Christmas light experience on the Bremer Farm near Hastings. The Dakota County Farm Bureau helped with signage that was placed throughout the grounds showcasing dairy products and farm facts.




Hunger Solutions Grants

The Foundation offers a grant program supporting county Farm Bureaus in their efforts to work alongside organizations addressing food insecurity in their communities. In 2022, 28 grants were distributed, and several counties worked with local businesses to match funds, raising a total of \$10,859 in support. Counties gave back in a variety of ways, including food and monetary donations, volunteer time and packaging or serving meals.
